

DISTRICT 1

Beginning at the intersection of Harlem Avenue and Offner Road, go north on Harlem Avenue approximately 6 miles to the intersection of Steger Road. Go east on Steger Road to the intersection of Central Avenue. Go south on Central Avenue to the intersection of University Parkway. Go east on University Parkway to the intersection of Governors Highway. Go southwest on Governors Highway to the intersection of Dralle Road. Follow Dralle Road east and south and east again until it intersects with Steger Monee Road. Follow Steger Monee Road northwest to the intersection of University Parkway. Go northwest on University Parkway to the intersection of Kedzie Avenue. Go south on Kedzie Avenue as if it were extended to the intersection of Hickok Avenue. Go west on Hickok Avenue until the intersection of Kedzie Avenue, as if Kedzie Avenue extended south. Continue south until Kedzie Avenue, as if it were extended, intersected with Deer Creek. Follow Deer Creek southwest until it hits Crete Monee Road. At the intersection, go west on Crete Monee Road until the intersection of Will Center Road. Go south on Will Center Road until it intersects with West Main Street. Go west on West Main Street to the intersection of South Eastgate Avenue. Go south on Eastgate Avenue 1 block to the intersection of West Holden Street. Go west on West Holden Street 1 block to the intersection of Elmwood Lane. Go south on Elmwood Lane 1 block to the intersection of West Margaret Street. Go 2 blocks west on West Margaret Street to the intersection of South Oakwood Avenue. Go 2 blocks south on Oakwood Avenue to the intersection of West Mills Street. Go west on West Mills Street approximately 5 blocks to the intersection of Oak Road. Go southwest on Oak Road to the intersection of West

Orchard Trail. Go west on West Orchard Trail as if it were extended, to the intersection of the Illinois Central Railroad tracks. Go southwest on the Illinois Central Railroad tracks until the intersection of Laurel Lane, as if Laurel Lane extended west to the Illinois Central Railroad tracks. Go east on West Laurel Lane to the intersection of South Egyptian Trail. Go south on South Egyptian Trail to the intersection of Offner Road. Go west on Offner Road to the point of beginning, at the intersection of Harlem Avenue.

DISTRICT 2

Beginning at the intersection of Goodenow Road and Egyptian Trail, go east on Goodenow Road to the intersection of South Kuersten Road. Go north on South Kuersten Road to the intersection of Glendorf Road. Go east on Glendorf Road to the intersection of Blackhawk Drive. Go north on Blackhawk Drive to the intersection of Crete Monee Road. Go east on Crete Monee Road to the intersection of Western Avenue. Go north on Western Avenue to the intersection of Hickok Avenue. Go west on Hickok Avenue to the intersection of Union Drive. Go north on Union Drive to the intersection of Sandra Drive. Go west on Sandra Drive to the intersection of Burnham Drive. Go south on Burnham Drive to the intersection of Hickok Avenue. Go southwest on Hickok Avenue to where it merges with Hamilton Road. Go west on Hamilton Road to a point of intersection with Kedzie Avenue, as if Kedzie Avenue were extended. Go south on Kedzie Avenue until it intersects with Deer Creek. Follow Deer Creek southwest until it intersects with West Crete Monee Road. At the intersection, go west on Crete Monee Road until the intersection of Will Center Road. Go south on Will Center Road until it intersects with West Main Street. Go west on West Main Street to the intersection of South Eastgate Avenue. Go south on South Eastgate Avenue 1 block to the intersection of West Holden Street. Go west on West Holden Street 1 block to the intersection of Elmwood Lane. Go south on Elmwood Lane 1 block to the intersection of West Margaret Street. Go 2 blocks west on West Margaret Street to the intersection of South Oakwood Avenue. Go 2 blocks south on Oakwood Avenue to the intersection of West Mills Street. Go west on West Mills Street approximately 5 blocks to the intersection of Oak Road. Go southwest on Oak Road to the intersection of West

Orchard Trail. Go west on West Orchard Trail as if it were extended, to the intersection of the Illinois Central Railroad tracks. Go southwest on the Illinois Central Railroad tracks until the intersection of Laurel Lane, as if Laurel Lane extended west to the Illinois Central Railroad tracks. Go east on West Laurel Lane to the intersection of South Egyptian Trail. Follow South Egyptian Trail south until the point of beginning at the intersection of Goodenow Road.

DISTRICT 3

Beginning at the intersection of Niagra Street and Steger Road, as if Steger Road were extended. Go west on Steger Road to the intersection of Central Avenue. Go south on Central Avenue to the intersection of University Parkway. Go east on University Parkway to the intersection of Governors Highway. Go southwest on Governors Highway to the intersection of Dralle Road. Follow Dralle Road east and south and east again until it intersects with Steger Monee Road. Follow Steger Monee Road northwest to the intersection of University Parkway. Go northwest on University Parkway to the intersection of Kedzie Avenue. Go south on Kedzie Avenue as if it were extended to the intersection of Hickok Avenue. Go east on Hickok Avenue to the intersection of Burnham Drive. Go north on Burnham Drive to the intersection of Sandra Drive. Go east on Sandra Drive to the intersection of Union Drive. Go south on Union Drive to the intersection of Hickok Avenue. Go east on Hickok Avenue to the intersection of Western Avenue. Go north on Western Avenue to the intersection of Sycamore Drive. Go west on Sycamore Drive, as if it were extended to a point where it would intersect with Neosho Street if Neosho Street extended south. Go north on Neosho Street, as if it were extended to Monee Road. Go east on Monee Road to the intersection of Niagra Street. Go north on Niagra Street to the point of beginning.

DISTRICT 4

Beginning at the intersection of Steger Road and Tieri Lane, as if Tieri Lane extended north, go west on Steger Road to the intersection of Niagra Street as if Steger Road were extended. Go south on Niagra Street to the intersection of Monee Road. Go west on Monee Road to the intersection of Neosho Street, as if Neosho Street extended south to Monee Road. Go south on Neosho Street, as if it were extended south, to the intersection of Sycamore Drive, as if Sycamore Drive extended west. Go east on Sycamore Drive, as if it were extended to the intersection of South Western Avenue. Go south on Western Avenue to the intersection of Crete Monee Road. Go east on Crete Monee Road to the intersection of Main Street. Go north on Main Street to the intersection of Exchange Street. Go west on Exchange Street to the intersection of Washington Avenue. Go north on Washington Avenue for 4 blocks to the intersection of 1st Street. Go east on 1st Street 1 block to the intersection of Lincoln Avenue. Go north 2 blocks on Lincoln Avenue to the intersection of 2nd Street. Go east on 2nd Street 1 block to the intersection of Columbia Street. Go north on Columbia Street as if it were extended to Norfolk Road, as if Norfolk Road were extended east. Go west on Norfolk Road as if it were extended to the intersection of Tieri Lane as if Tieri Lane were extended south. Go North on Tieri Lane, as if it were extended to Steger Road, to the point of beginning.

DISTRICT 5

Beginning at a point approximately 500 feet west of State Street on Steger Road go south along the Crete-Monee Community Unit School District 201-U district boundary to the intersection of the Crete Bike trail and Bradford Drive. Follow the Crete-Monee Community Unit School District 201-U boundaries west to Dorsetshire Drive and continue following the district boundary south on Dorsetshire Drive to a point in Lincoln Oaks Golf Course and continue following the District boundaries west to Columbia Street. Go south on Columbia Street to the intersection of 2nd Street. Go west 1 block on 2nd Street to the intersection of Lincoln Avenue. Go south on Lincoln Avenue 2 blocks to the intersection of 1st Street. Go west on 1st Street 1 block to Washington Street. Go south on Washington Street, approximately 4 blocks to West Exchange Street. Go east on West Exchange Street to the intersection of Main Street. Go south on Main Street to the intersection of New Monee Road. Go east on New Monee Road to a point approximately 500 feet west of State Street. Go due north to Burville Road. Go east on Burville Road to South Cottage Grove Avenue. Go south on South Cottage Grove Avenue to the intersection of Old Mud Road. Go west on Old Mud Road to the intersection of East Bemes Road. Go south and east along East Bemes Road to the intersection of Stoney Island Avenue. Follow Stoney Island Avenue north and west to the point of intersection with Burville Road. Go west on Burville Road to Illinois 394 (Bishop Ford Freeway). Follow Illinois 394 (Bishop Ford Freeway) north to the intersection of Richton Road. Go west on East Richton Road to a point approximately

500 feet east of Crete Road. Go due north to Steger Road. Follow Steger Road west to the point of beginning.

DISTRICT 6

Beginning at the northeast boundary of the District, go west on Steger Road to a point approximately 500 feet east of Beckwith Lane. Go due south to Richton Road. Go east on Richton Road to the intersection of Illinois 394 (Bishop Ford Freeway). Go south on Illinois 394 (Bishop Ford Freeway) to the intersection of Exchange Street. Go east on Exchange Street to the eastern boundary of the District at State Line Road. Follow State Line Road north, as if it were extended to the point of beginning at Steger Road.

DISTRICT 7

Beginning at the southeast corner of the District boundaries at the intersection of State Line Road and Offner Road. Go west on Offner Road to the intersection of South Egyptian Trail. Go north on South Egyptian Trail to Goodenow Road. Go east on Goodenow Road to the intersection of South Kuersten Road. Go north on South Kuersten Road to the intersection of Glendorf Road. Go east on Glendorf Road to the intersection of Blackhawk Drive. Go north on Blackhawk Drive to the intersection of Crete Monee Road. Go east on Crete Monee Road to a point approximately 500 feet west of State Street. Go due north to Burville Road. Go west on Burville Road to South Cottage Grove Avenue. Go south on South Cottage Grove Avenue to the intersection of Old Mud Road. Go west on Old Mud Road to the intersection of East Bemes Road. Go south and east along East Bemes Road to the intersection of Stoney Island Avenue. Follow Stoney Island Avenue north and west to the point of intersection with Exchange Street. Follow Exchange Street east to South State Line Road. Go south on State Line Road to the intersection of Offner Road, to the point of beginning.
